## PERMISSION TO BRING CHILDREN OF LEADERS/ADULTS TO PEAK 2010 TO BE COMPLETED BY CAMPERS

This form must be filled in for all children who are not Scouts or Guides. It does include Beavers, Rainbows, Brownies & Cubs and children under 16 who are not invested in Scouting or Guiding. **Please note that this does not guarantee a place in the activity clubs.** Whilst at camp the responsibility for the well being of children lies with the parent(s)/carer(s). Permission to bring children of Leaders / Adult Helpers should be obtained in the first instance from the Leader of your group camp and approved by your Group Scout Leader (GSL) or Commissioner. Final approval lies with the Campers' Manager.

Peak 2010 will be operating 3 Activity Clubs for Children. The ages will be 2 to under 5, 5 to under 8, 8 to under 10½ (to accommodate those youngsters who are Cubs not Scouts). All ages as of 31<sup>st</sup> August 2010. Priority for places will be as follows:

- Priority 1                    staff (a limited number of places are available for campers)
- Priority 2                    campers - where both parents/carers are on site or where parent is a single parent
- Priority 3                    campers - where one parent/carer is on site and is not a single parent

Places not requested by staff will become available to campers following the above priority rules.

Children aged 10 - maximum 16 at 31/08/2010 may take part in the camp activities on payment of the full camp fee, £155.

Places at camp for children will not be considered unless this form is returned with the Booking Form and it has been signed by the Leader of your group camp and approved by your GSL or Commissioner. A tick in the appropriate box will request the booking forms for Activity Club, Activities and Special Needs which will be sent with the confirmation of children's **places at the camp** (It may not be possible to confirm places in the club until the end of December 2009).
